#### **Covid 19 Restrictions:**

Sadly the County is still under Covid -19 restrictions. However we look forward to a relaxation in the Spring. In the meantime stay safe and well, despite what seems to be turning into a 'proper' winter.

### **Flooding Preparations:**

In the light of our winter weather our Clerk has worked alongside the other agencies who form part of our Community Emergency Plan to obtain supplies of sandbags for use around the village. We still hold a quantity of these sandbags in our lockup, if anyone is in need of these, please contact the Clerk, to make arrangements for collection.

We take this opportunity to thank villagers and the Village Hall for their co-operation.

#### **Defibrillators:**

We are pleased to advise that the new Defibrillator is now installed at the Church and in working order should this be required.

The defibrillator box outside the Village Hall has been replaced with a new unit and spare pads purchased. Unfortunately it is used on a fairly frequent basis.

#### **Failing River Wall:**

A very obvious change to the village scene is the collapse of a stretch of the wall below the Plantation land by the River Aire. We are in close contact with the Environment Agency as to what is acceptable to them going forward both as already planned and in the short term. This all river level dependent. The Parish Council thanks concerned villagers for alerting us to the collapse on the off chance that we were not aware.

The wall has been monitored for a long time and the programme for the work necessary developed over many months, as will be apparent from the Parish Council Minutes on our website.

#### **Temporary Closure of Post Office:**

We have been notified of the temporary closure of the Post Office. The Parish Council wishes the Postmaster and Postmistress and their family all the best for their future and thanks them for their work on behalf of the village.

## AJ1 Project Update:
