Good afternoon Gavin,

Thank you for delivering the final model outputs and report as requested. I have cleaned the final duplicate node from the 1%+50CC AEP outline and can confirm that the delivered outlines are now in a suitable format.

Please accept this email as confirmation that the data and evidence team (with support from Modelling and Forecasting) consider the model provided for *Skipton Road, Gargrave* as fit for purpose.

As previously stated, the Environment Agency prefer not to change the flood map in the same area in consecutive updates or too frequently, as this reduces data confidence in the area. New modelling of Eshton Beck is due to be delivered in time for a Flood Map update next year. Your final outlines will be reviewed alongside the outputs from this new modelling, and a decision will then be made as to which model is most appropriate for updating the Flood Map. In the interim, the flood map will not be changed and your model and outputs can be used to inform your planning application.

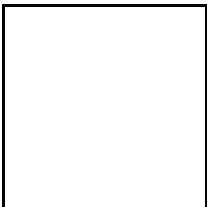
